Professor Dr. Shah Nowaz Ali joined the Department of Management, University of Rajshahi in 1976. Dr. Ali has a uniform career all along. He did his M.Com from Rajshahi University in 1974 obtaining first class second position. Dr. Ali obtained his Ph.D. in 1997 on Procurement Management of Sugar Industries while he was discharging his responsibility as Chairman, Department of Management. He was the Dean of the Faculty of Business Studies for two terms and member of both the Syndicate and Senate of Rajshahi University. In addition, he discharged his duties as Chairman of the Department of Management Studies. Dr. Shah Nowaz was Vice-President and member of Rajshahi University Teachers' Association. He was also the Senate member at National University. He discharged his duty in many responsible positions of Rajshahi University. He was the founder editor of "Journal of Business Studies", Rajshahi University. He possesses a lot of research publications to his credit. Dr. Ali is also a columnist. He was elected twice the Convener of Progotishil Shiksak Samaj (Progressive Teachers' Association) of Rajshahi University.
