#### **Editor's Note**

A delegation of the University Grants Commission (UGC) led by its Chairman Professor Dr. Kazi Shahidullah submitted its 48th Annual Report-2021 to President Md. Abdul Hamid at Bangabhaban on 12 January 2023.

The report submitted to the President contains a total of 17 recommendations to ensure quality education, innovation, creating new knowledge, and excellence at the university level.

The major recommendations of the report are - development of an implementable guideline to appoint a vice-chancellor, pro-vice-chancellor, and treasurer based on the opinion of UGC; empower UGC to implement the recommendations made by different inquiry committees regarding the irregularities in public universities; formulation of an audit standard, code of ethics, and audit manual the higher education institutes; closure of evening courses in public universities; formation of guidelines to determine the logical amount of land for setting up public university campuses, introduction of an integrated financial guideline and financial manual to restore financial order in the universities, establishment of a university teachers' training academy to develop quality teachers, a central research laboratory for conducting quality research, and a national research council for identifying sectors to conduct research.

Inclusion of the recommendations in the report will bring no visible changes in the quality of higher education unless effective and time-bound measures are taken to implement the recommendations. It is expected that execution of the constructive recommendations would take the country's higher education to the next level of excellence.

Finally, we sincerely thank Chief Advisor, members of the editorial board, concerned officials of PRRI Division of UGC for their wholehearted cooperation to publish the bulletin in time.

#### **UGC's Annual Report-2021 submitted to President**



A delegation of the University Grants Commission (UGC) led by its Chairman Professor Dr. Kazi Shahidullah submitted its 48th Annual Report-2021 to President Md. Abdul Hamid at Bangabhaban on 12 January 2023. Other members of the delegation are -UGC Members Professor Dr. Dil Afroza Begum, Professor Dr. Md. Sazzad Hossain, Professor Dr. Muhammed Alamgir, Professor Dr. Biswajit Chanda and Professor Dr. Abu Taher and UGC Secretary Dr. Ferdous Zaman.

At the meeting the UGC chairman briefed the President on various aspects of the report and the overall activities of the UGC. He informed to the President that the UGC's research budget has been substantially increased to inspire different research activities in the universities and different policies have been formulated for smooth running of the university's academic and administrative activities.

The report submitted to the President contains a total of 17 recommendations to ensure quality education, innovation, creating new knowledge, and excellence at the university level.

It has been mentioned in the recommendations that most public universities had no fixed policies or methods for appointing vc, pro-vc, and treasurer, and no opinion was sought from the UGC in their appointment process. The report suggested the government prepare an implementable guideline to appoint a vc, pro-vc, and treasurer based on the UGC's opinion.

The UGC said it usually sends reports to the education ministry with recommendations if any irregularities are found, but those recommendations are hardly implemented. The UGC sought power from the government to implement its own recommendations over irregularities.

'It has become urgent for the commission to have the legal power following irregularities in the appointment of the universities' teachers, officials, and employees; admission of extra students; implementation of development projects; allegations of certificate business; and financial irregularities in financial issues,' said the report.

The UGC report, in another recommendation, said that for ensuring accountability and responsibility in the accounting system, auditing was very necessary. The government and the

commission can take effective steps to prepare an audit standard, code of ethics, and audit manual, it said.

The report also recommended that evenina in courses public universities be closed and that every university should have an academic master plan on an urgent basis for producing skilled manpower and ensuring international **standards** in education. The UGC said that universities could prepare master plans in coordination with the commission.

The UGC also recommended the formation of guidelines to

determine the logical amount of land for setting up public university campuses, another guideline for the introduction of academic activities, and an integrated financial guideline and financial manual to restore financial order in the universities.

The recommendations also included the establishment of a university teachers' training academy develop quality research teachers, central laboratory for conducting quality research, and a national research council for identifying sectors to conduct research.

#### Govt plans to implement smart files in all offices: Zunaid Ahmed

State Minister for Information and Communication Technology Division Junaid Ahmed Palak said that the government has set the goal of implementing smart file, an updated version of digital file, in building a smart Bangladesh. Information and Communication Technology Division is working on the process of linking artificial intelligence, big data analysis, block chain and other frontier technologies with digital file to develop the system. He said that this initiative is being taken to ensure transparency, accountability in government work and establishment of paperless offices.

He made the remarks while delivering address at the launching of D-file system in public universities of the country on 26 February 2023 at UGC auditorium.

Chaired by UGC Chairman Professor Dr. Kazi Shahidullah, the function was addressed by the UGC Member Professor Dr. Md. Sazzad Hossain, Vice-Chancellor of Shahjalal University of Science & Technology Professor Farid



Uddin Ahmed, Project Director of A2i Dr. Dewan Muhammad Humayun Kabir, UGC Secretary Dr. Ferdous Zaman and Director of the IMCT Division Mohammad Maksudur Rahman Bhuiyan.

Minister Junaid Ahmed stated that the government is working to establish a cashless society and paperless office as building part of а smart Bangladesh by 2041. As part of this, all the universities of the country will be turned paperless step by step. He advised the university authorities to make gradually all the financial transactions cashless.

He said that in the last six years, more than 1 lakh officials in 11,000 offices of the government have disposed of more than 2 crore files through e-file system. Digital delivery of government services has saved money and time with a financial value of about \$21 billion.

Professor Dr. Kazi Shahidullah said, we are entering into Smart Bangladesh from the Digital Bangladesh, He opined that service seekers will get smart services and their suffering will be reduced once digital file system is implemented. He advised the university authorities to be serious in implementing digital file.

UGC Members Professor Dr. Dil Afroza Begum and Professor Dr. Md. Abu Taher, Vice-Chancellors of Hajee Mohammad Danesh Science and Technology University, Mawlana Bhashani Science and Technology University, Chittagong University of Science and Technology, Noakhali Science and Technology University, Bangabandhu Sheikh Mujibur Rahman Maritime University, and Sheikh Hasina University attended the function.

Relevant officials from UGC, a2i and universities were also present at the event which was conducted by Deputy Director of the IMCT Division of UGC Mohammad Monir Ullah.

#### **UGC** holds views exchange meet with VCs

The University Grants Commission of Bangladesh has informed that a total of 22 general and science and technology universities of the country, including Jagannath and Islami universities, will participate in the cluster admission test for the academic year 2022-2023.

The UGC has directed the universities under the cluster to arrange the admission test within a quickest possible time and start the classes after completing the admission process. The organizers have been advised to be careful to make the admission test process easy and student friendly and to make the cluster admissions unique.

Besides, it has been reported that an integrated admission test will be organized in all universities of the country in the academic year 2023-2024.

This decision was taken in a meeting held at the UGC on Monday regarding the arrangement of the cluster admission test for the academic year 2022-2023 without any flaw and interruption.

UGC Chairman Professor Dr. Kazi Shahidullah presided over the meeting which was attended by



the UGC Members Professor Dr. Dil Afroza Begum, Professor Dr. Muhammed Alamgir, Professor Dr. Biswajit Chanda and Professor Dr. Md. Abu Taher, UGC Secretary Dr. Ferdous Zaman, Director of the Public University Management Division Mohammad Jaminur Rahman and relevant officials of UGC.

The meeting discussed elaborately the existing problems of cluster admission system and their possible solutions. It also discusses how to overcome last year's complications in admissions and how to make admissions easier and student friendly.

UGC Chairman Professor Dr. Kazi Shahidullah said, the cluster admission system has been highly appreciated by the admission seekers, their guardians and academicians of the country. They termed it as a good test method. There might be some problems in holding the test in the new system, but there is no way to back out. He urged the Vice-Chancellor and others involved in holding the cluster admission test to be sincere to make the test ensure accepted to all.

The UGC chairman advised the concerned authorities to be sensitive in implementing the government's desire regarding the cluster admission test.

#### UGC Chairman calls on private universities to comply with regulations

The Chairman of University Grants Commission of Bangladesh Professor Dr. Kazi Shahidullah has urged the Vice-Chancellors of private universities to follow the existing rules and regulations. He made this call in a views-exchange meeting with the Vice-Chancellors to bring transparency and dynamism in academic and administrative activities of private universities.

The Private University Division of UGC organized the meeting on 22 March 2023 to ensure quality in higher education and research.

UGC Member Professor Dr. Biswajit Chanda spoke as the



keynote speaker at the event. Vice-Chancellors of 69 private universities appointed by the Honourbale President participated in the meeting and took part in open discussion. UGC Secretary Dr. Ferdous Zaman and Director of Private University Division Md. Omar Faruque delivered the speech at the event.

Professor Kazi Shahidullah in the meetina stated that Vice-Chancellors should stand against any corruption and irregularities. He urged the VCs to run the university in accordance the existing laws regulations and let UGC know in writing if they face any problems. UGC will stand by you if anyone tries to undermine your just rights, he said.

Regarding permanent campuses, he said, legal action will be taken against those universities which are hesitating to go to permanent campuses or have not taken any initiative even after 12 years of establishment. Besides, he also suggested opening the department and admitting students after completing the proper process. He urged the Board of Trustees and Vice-Chancellors to develop a system and discipline to ensure quality education in private universities.

Professor Dr. Biswaiit Chanda said Vice-Chancellors that the bv honourable appointed President in private universities are eminent academicians and respected persons of the society. He urged the Vice-Chancellors to performing viailant in responsibilities as per the Private Universities Act 2010.

Professor Chanda said that attempts are being made to ensure that VC, Pro-VC and Treasurer in

private universities get appointment without delay. He also said that the UGC is working to empower the Vice-Chancellors of private universities and if any major decision is taken, the Vice-Chancellors will be consulted.

Vice-Chancellors in the views-exchange meeting raised few important issues which includes amendment of the Private University Act, allow private universities to give Mphil and PhD degrees conditionally, reduce the lengthy procedure for appointing Vice-Chancellors. Vice-Chancellors and Treasurers, increase the power of Vice-Chancellors in runnina universities, make provision to the take opinion of Vice-Chancellors in taking important decisions to improve the quality of education and research in private universities, introduce uniform grading system, implementation of minimum pay structure. allocate budget in research sector for private universities. formulate service rules, formulate of strategic plans, develop inter-university research networks, quick release of foreign funds for research and declare Ashulia as an Education City.

Senior officials of UGC were present at the meeting which was conducted by the Senior Assistant Director of UGC Shahnaz Sultana.

## UGC urges universities to properly follow financial rules

UGC Chairman Professor Dr. Kazi Shahidullah called upon the Vice-Chancellors to properly follow the government rules and regulations in spending money in public universities.

The UGC chairman made the call while delivering address at the opening ceremony of the workshop titled' Formulation of

budget for public universities and its implementation' as the Chief Guest on 12 January 2023.

Presided over by UGC Member Professor Dr. Md. Abu Taher, the day-long workshop held on the virtual platform, was addressed by the Additional Director of Finance and Accounts Division of the Commission Md. Rezaul Karim Hawladar and Deputy Director of the Directorate of Education Audit Shakila Zaman.

UGC Chairman in his speech stated that financial irregularities of the organizations are now a major headache for the government. He called upon all concerned to properly comply with the existing rules on financial matters to

prevent financial irregularities in public universities and bring down audit objections to zero level.

He directed the officials concerned to deliver the appropriate interpretation of the rules and regulations before the university authorities, coming out of all kinds of inhibitions. He also said that if a person makes concessions in financial matters, he will have to take responsibility for the crime.

UGC Chairman also said that allegations of serious financial irregularities against some public universities are being published in the media. Being in charge of supervision, UGC also has to take responsibility for this. Unpleasant words are also being heard from the concerned Parliamentary Standing Committee and the office of the Comptroller and Auditor General. He said that UGC is strengthening the audit program to prevent financial irregularities.

He urged the Audit Cell to play a strong role in maintaining the reputation of public universities and in running the university smoothly.

Abu Taher in his speech urges relevant authorities of public universities to prevent financial irregularities and maintain financial discipline in public universities. He called for proper utilization of resources, ensure transparency and accountability and establishment of good governance to deal with the financial crisis. He also urged everyone to maintain austerity in all areas due to the global economic crisis.

He requested the Vice-Chancellors to make the Audit Cell of the University completely independent and

ensure a proper working environment to prevent the recurrence of irregularities.

Besides, the UGC has suggested conducting audits with professional accounting personnel to ensure transparency and accountability in the accounting system and bring down audit objections to zero level.

Conducted by Robiul Islam, Senior Assistant Director and Innovation Focal Point of UGC, the workshop was participated by the heads of finance and accounts divisions and relevant officials of audit cells of 48 public universities.

### UGC's initiative to use software to bring financial transparency in universities

The University Grants Commission of Bangladesh (UGC) has taken the initiative to use software to strengthen financial transparency and discipline and to ensure speedy service delivery in the country's public universities. Besides, initiatives have also been taken to modernize the audit cell.

In this regard, Professor Dr. Md. Abu Taher said, the use of 'Audit Management and Monitoring System 2.0' software will increase transparency, accountability and dynamics in the financial sector and transparency in the audit process.



He said this in the speech of the chief guest at the inauguration of the day-long training on 'Audit Management and Monitoring System 2.0' software. UGC organized the training at

Chittagong University (CU) on 25 March 2023.

Professor Dr. Shireen Akhter, Vice-Chancellor of the University of Chittagong, presided over the inaugural ceremony of the training where Professor Benu Kumar Dey, Pro-Vice Chancellor (Academic), was the Special Guest. Md. Rezaul Karim Hawlader, Additional Director, Finance and Accounts Division of UGC and Mohammad Amimul Ehsan Kabir, Director, Directorate of Education Audit, conducted sessions as the resource persons.

Professor Md. Abu Taher said that the current government is determined to ensure transparency and accountability in all areas including finances in public universities. Various action plans are being implemented to ensure transparency and accountability in diffrent sectors of the government.

He said that through this training, the concerned persons will get important guidance in carrying out financial audit and will find specific guidelines in the management of audit cell of the university.

Professor Dr. Shireen Akhter in

her speech stated that Audit plays a vital role to ensure financial transparency, accountability and good governance in every organizations. The participants of today's training will play important role in ensuring the financial transparency accountability in their respective organizations by applying the knowledge they gained from the experts of the training.

UGC Chairman in said in the meeting that education has turned a big business in the world. But education system or investment in education in Bangladesh is not for business purpose. Education should be treated as a social responsibility rather than commodity. He also said that foreign investment in education in Bangladesh should be meaningful and student-friendly.

#### Malaysia to give scholarships to university teachers

The Xiamen University Malaysia has decided to provide 10 scholarships for Masters and Ph.D programs for university teachers in the country.

The decision was disclosed in a meeting held between UGC Member Professor Dr. Biswajit Chanda and President of Xiamen University Malaysia Professor Wang Ruifang at UGC meeting room on 02 March 2023. A four-member delegation from Xiamen University Malaysia led by Professor Wang Ruifang participated in the meeting.

Professor Wang Ruifang said the Xiamen University Malaysia is

giving the scholarships under the Memorandum of Understanding signed between UGC and Xiamen University Malaysia in 2019. Under the MoU, the university teachers of Bangladesh will be given scholarships in Maritime, Marine Technology, Deep Learning, AI, Cyber Security and Mechatronics.



In the meeting, Professor Dr. Biswajit Chanda said, under this agreement, cooperation will be available carrying in out collaborative research and development of learning teaching methods in the higher education institute of Malaysia. He opined that scholarship, education and research facilities, Masters and PhD programs in Xiamen University Malaysia will play a role in improving the quality of higher education and research in our country.

He also said that Bangladesh has

the opportunity to work jointly with Malaysia in many areas of higher education. Both countries will be benefited if this possibility is fully utilized. He said that necessary cooperation will be provided by UGC in this case.

Notably, Xiamen University Malaysia is the first overseas campus established by a famous Chinese university and the first Chinese university branch campus in Malaysia.

UGC Secretary Dr. Ferdous Zaman, Director of the Research Support and Publication Division Dr. Md. Fakhrul Islam and relevant UGC officials was present at the meeting.

UGC will help fulfill the government's commitment to establish paperless offices.


building a Smart Bangladesh announced by Prime Minister Sheikh Hasina.

#### UGC calls for quick arrangement of cluster admission test



The University Grants Commission of Bangladesh (UGC) has called upon the relevant public universities to quickly organize the admission test for the academic year 2022-2023 in cluster system.

UGC Member and Convener of the relevant committee, Professor Dr. Muhammed Alamgir, urged the relevant public universities to organize a fair and smooth admission test utilizing the experience of the previous years and issue notice for admission mentioning the date for the start

and end of the admission process and the start of the education activities.

He made this call on 06 March 2023 in a review meeting related to the completion of admission tests and admission programs in public universities in the academic year 2021-2022.

Held in virtual platform, the meeting was joined by UGC Member Professor Dr. Md. Professor Md. Abu Taher stated that all the conditions and related to the information admission test should be mentioned in the circular and prospectus and these conditions should be kept unchanged until the admission process is completed.

He also urged the concerned committee to take measures to allow students to take part in admission test at the place of their choice. Besides, he also suggested updating the software used in the admission test process to make it student friendly.

#### UGC focuses on quality of education, not increase in number

Professor Dr. Muhammed Alamgir has called on all concerned to focus on ensuring the quality of education rather than increasing the number of students in higher education institutions.

He made the call during an exchange of views with a delegation of two members of Nottingham University. The meeting was held on 31 January 2023 at the office room of

Professor Muhammed Alamgir.

The University of Nottingham is providing subject-specific training to teachers engaged in higher education in colleges across the



country to improve their teaching skills Under the College Education Development Project (CEDP). In the meeting, the delegation highlighted various aspects of the progress of teachers' training.

In the meeting, Professor Alamgir said that teachers, laboratories and infrastructure are very important in launching any program in higher education institutions. But, many universities of the country are starting education programs without fulfilling these conditions which is very unfortunate. Due to this, the country is deprived of producing quality graduates suitable for the labor market. He said that attention should be paid to ensure

that students are not deprived of quality higher education.

The UGC Member also said that the government should be more sincere in ensuring the quality of higher education at the college level. For this purpose, curriculum should be designed that meets market demands and teachers should be trained. He said that the relevant authorities should focus on providing career-oriented and skill-based higher education rather than allowing the opening of Honors and Masters courses in colleges.

Rozilini Mary Fernandez Chung, director of the Centre for Academic Partnership and Engagement of the Malaysian campus of the University of Nottingham, Ranjit Singh Gill, Associate Professor of the same university and Dr. AKM Khalilur Rahman, Senior Program Officer of CEDP were present at the meeting.

#### **UGC Member exchanges views with Nepalese delegation**

A delegation of Nepal Development Research Institute (NDRI) held a views-exchange meeting with University Grants Commission of Bangladesh. The meeting was held on 27 February at the UGC meeting room with UGC Member Professor Dr. Md. Sazzad Hossain in the chair.

Members of the Nepalese delegation Nav Raj Khatiwada and Dr. Shankar Shrestha, President and Executive Director of NDRI respectively and Dr. Jyoti Giri, Associate Professor of Tribhuvan University, participated in the views-exchange meeting which was led by former Minister of Environment, Science and Technology Affairs Nepal Ganesh Shah.

Professor Dr. Md. Sazzad Hossain in his speech delivered an overview



about the higher education scenario of Bangladesh. He said, Bangladesh has the opportunity to work jointly with Nepal in many areas of higher education. Both countries will

President of NDRI Nav Raj Khatiwada said that many students from Nepal come to Bangladesh to pursue medical and engineering studies. On the other hand, Nepal has a long experience in tourism and hospitality management education. In this case Bangladeshi

students can complete a part of their education in Nepal.

UGC Member Professor Dr. Md. Sazzad Hossain requested the delegation of NDRI to send a specific proposal through identifying the areas of joint cooperation in higher education. He assured the delegation that necessary cooperation will be provided by UGC in this regard.

#### **UGC** issues public notice regarding 18 private universities

The University Grants Commission of Bangladesh (UGC) has issued a public notice on 19 January 2023 regarding actions to be taken against 18 private universities that failed to shift all activities to permanent campuses within the stipulated time frame.

It has been mentioned in the notice that the UGC decided to stop the admission of new students in all programs in four private universities of the country as no visible steps were taken by these universities to transfer all the activities to the permanent campus and to build the campus within the stipulated period in complying with the letter issued by UGC earlier.

The universities are Stamford University Bangladesh, Asa University, Prime Asia University and Victoria University.

The admission of new students in the temporary campuses of State University and Manarat International University will be completely closed. However, the programs conducted at the permanent campuses of these two universities will continue as usual.

Dhaka International University, Royal University, Southeast University, City University, The



Millennium University and Bangladesh University have been given time till 31 March 2023 to transfer their entire activities including educational programs to the permanent campus, considering the visible progress regarding the transfer to the permanent campus and construction of the campus in complying with the letter of UGC.

In case of failure to transfer all programs including educational programs to the permanent campus within the mentioned time frame, the admission of new students in all programs will be completely stopped from 1 April 2023.

The notification also said that considering the visible progress and written commitment regarding the transfer to the permanent campus and the construction of the campus, BRAC University,

University of Development Alternative, Green University, Uttara University, Presidency University and The People's University have been given time to transfer all education programs to the permanent campus by 30 June 2023.

In case of failure to transfer the includina entire program educational programs to the permanent campus within the stipulated time frame. the admission of new students in all programs will be completely stopped from July 1, 2023 in the concerned universities.

All temporary campuses or buildings other than the permanent campus of these universities will be considered illegal.

According to the public notification, the University Grants Commission issued a letter on 11 April 2022 directed the universities whose temporary certificates expired and were not transferred to the permanent campus to transfer to the permanent campus by 31December 2022. The admission of new students would be stopped from 01 January 2023 if these universities failed to comply with the instructions of the letter.
